
The Challenge- FSA Priorities and the Role of Data

- 2016- Summary of a research literature survey to capture the landscape of the role of the **internet of things (IoT)** in the safety and security of food.





Smart Sensor Trial

- **Three-month trial** saw five businesses in the Cambridge area replace their paper-based food safety management processes with **Checkit's** digital solution; **Data exchange between FBOs, LAs & FSA**
- Daily compliance checks recorded via wireless sensors and the results automatically uploaded to the cloud for storage (digitally time stamped and tamper-proof).





Smart Sensor Trial

- Through the cloud-based control centre, users can access records remotely, receive alerts on any anomalies and track performance in **real-time**.
 - Help inform the decision making approach for auditors and inspectors (**better regulatory judgements**)
 - **Increase efficiency** of food safety inspections by **concentrating on high risk businesses**
 - Support businesses with **regulated assurance** of food safety
 - **Improved transparency** between businesses and regulator- **Trust in a robust system**
 - **Optimise public protection**

Allergy Alerts

New allergy alerts service, powered by **APIs**, to get information about food recalls and withdrawals to businesses and consumers quicker.



FSA Open Data Policy

- 'Open by Default' since January 2016
- Maintain approximately 70% of all our data assets as open data
- Food Hygiene Rating Scheme the most accessed dataset;
 - Provision of ratings on a range of 3rd party websites.
 - Supporting some unusual innovations including helping emergency services in the West Midlands better plan, model and respond to incidents.
